## Perspective Plan of the Institution

(2023-24 to 2027- 28)

- ❖ Amolakchand Vidhi Mahavidyalaya has been imparting legal education in this area mostly comprising of rural and tribal population, since 1962 as department and as separate college from 2006. The College is permanently affiliated to the University, we are also having Affiliation under Section 2(f) and 12(B) under UGC Act, 1956. The College is NAAC Accredited with B+ (CGPA 2.69). It is planning to make the tribal and rural student to compete globally. Accordingly, the College is trying to start post-graduation courses, diploma courses along with several add-on courses like Right to information, Law of Taxation, Local Self Governance etc.
- ❖ College is having highly qualified and experienced faculty. To enhance the competence and research aptitude among faculties and students, the College will provide research facilities and resources to them. The College is having Ph. D. Research Centre and P.G.
